The Public Meeting of the Conshohocken Borough Council duly advertised, was held at the Conshohocken Borough Hall, 400 Fayette Street, Conshohocken, PA. Ms. Sokolowski, Borough Council President, called the meeting to order at 7:05 PM.

COUNCIL PRESIDENT ANNOUNCEMENTS

Ms. Sokolowski announced that an Executive Session was held immediately prior to the regularly scheduled public meeting on property, personnel and legal matters.

PRESENTATIONS

a.) Consider approving a grant matching letter for a Local Share Account (LSA) grant application for the Fayette Street Road Diet Project

d.) Consider approving payment application no. 1 for the Traffic Signal Modernization Project along East and West Elm
